Item 5.07. Submission of Matters to a Vote of Security Holders.

We held our annual meeting of stockholders (the "Annual Meeting") on May 16, 2023. As of March 22, 2023, the record date for the Annual Meeting (the "Record Date"), we had 46,341,533 shares of Class A common stock outstanding and entitled to vote. There are currently no shares of Class B common stock outstanding. Holders of our Class A and Class B common stock are entitled to one vote for each share held as of the Record Date, with the exception that Class B common stock does not vote on the election or removal of directors.

At the Annual Meeting, shareholders voted in favor of the (1) re-election of the two Class I directors, Mary Egan and Robert Hartnett, to our Board of Directors, (2) approval, on an advisory (non-binding) basis, of the compensation of our named executive officers as disclosed in our proxy statement, (3) approval of the Noodles & Company 2023 Stock Incentive Plan, and (4) ratification of the appointment of Ernst & Young LLP as our independent registered public accounting firm. The final voting results were as follows:

(1) The following two individuals were re-elected as Class I directors, each to serve for three years and until his or her successor has been elected and qualified, or until his or her earlier death, resignation or removal.
